

Annex 1 - Mandatory Conditions

Supply of Alcohol (s19(2)&(3))

No supply of alcohol under the premises licence -

- (a) at a time when there is no designated premises supervisor, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence has been suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Exhibition of Films (s20(2))

Admission of children must be restricted in accordance with any recommendation by the British Board of Film Classification.

Annex 2 Conditions Consistant with the Operating Schedule

Prevention of Crime and Disorder

A CCTV system shall be installed and there after maintained at the premises in accordance with the manufacture instructions. The system shall be operational whenever the premises are open for licensable activities and recordings shall be maintained for a minimum of 31 days. Facilities

shall be made available for recordings to be viewed by the police and other responsible authorities on request and copies of recordings shall be provided in a playable format as soon as is reasonably practicable, provided the requests for viewing and or copies are made in compliance with Data Protection Legislation. To facilitate the provision of facilities for viewing and making copies of recordings, at least one member of staff shall either be on duty or available on call who has been trained in the use of the CCTV system. Should the CCTV system suffer a technical failure, the Police Licensing Officer will be advised and the system repaired as quickly as reasonably practicable.

At least one SIA registered door supervisor shall be deployed at the premises on every Friday and Saturday evening and on the New Year's Eve into New Year's Day from 22:00 hours until the premises are closed and the immediate area cleared of customers, unless otherwise agreed in writing by the police.

The premises will maintain an accurate up to date incident book which will be kept at the premises and made available for inspection by an authorised officer on request.

Annex 3 - Conditions attached after a Hearing by the Licensing Authority

- (1) Suitable signs shall be provided at each exit from the building requesting patrons to leave the area quietly.
- (2) There should be no external sound amplification after 2300hrs.
- (3) All external doors/windows must be kept closed after 2300hrs other than for access/egress, when events involving amplified music or speech are taking place.
- (4) Any power socket and hence the power supply used with any portable appliance being used in connection with the provision of and performance of live music and/or other portable equipment for amplified music brought on to the premises by the provider of the entertainment shall be connected via a residual current device (RCD) having a rating not exceeding 3 milli-amps. Should an RCD be considered inappropriate for use with a specified amplification system then the licensing authority must be informed of the reasons for this.
- (5) Other than on the day of the Gillingham Carnival, all reasonable steps shall be taken to prevent customers taking alcohol in open containers on to Gillingham High Street and a notice to the effect that customers are prohibited under licensing restrictions from taking drink outside shall be prominently displayed inside the premises on or near to the exit to the High Street.
