Annex 1 – Mandatory conditions

No supply of alcohol may be made under the premises licence –

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.

4. The responsible person must ensure that—

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1—

(a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) “permitted price” is the price found by applying the formula—

$$P = D + (D \times V)$$

where—

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence—

- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) “value added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (“the first day”) would be different from the permitted price on the next day (“the second day”) as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating Schedule

Prevention of Crime & Disorder

1. A written or electronic incident book and refusals register (either as a single document or separately) shall be kept and maintained at the premises.

The following shall be recorded:

Any occasion upon which a customer is refused service or alcohol and the reason for that refusal;

Any occasion upon which a customer is requested to leave the premises (other than at closing time);

Any incident involving the commission of an offence, anti-social or threatening behaviour occurring inside the premises or immediately outside;

Weekly checks of the CCTV system, any fault in the CCTV system and steps taken to rectify the fault.

The record shall be checked and signed by the DPS at least monthly and made available for inspection by Police or other authorised officers on request.

2. A digital CCTV system shall be installed and maintained at the premises. The cameras shall cover all public parts of the premises excluding the toilets. Recordings shall be accurately date and time stamped and retained for a minimum of 31 days.

The system shall be checked at least weekly to ensure that it is in good working order any fault rectified as soon as reasonably practicable. Facilities shall be made available for Police and other authorised officers to view recordings upon request and be provided with copies in a playable format as soon as reasonably practicable, provided all such requests are compliant with Data Protection regulations.

Public Safety

1. Any glasses that are renewed are replaced with glasses made from toughened glass, with the exception of wine and champagne.

Prevention of Public Nuisance

1. Save as might be permitted under the Live Music Act as amended or the auspices of any Temporary Event Notice Any temporary marquee erected in the external area shall only be used for licensable activities on 10 occasions each calendar year.

2. External areas shall be not used for eating or drinking after 23:00 hours. Use of external areas by persons wishing to smoke shall be supervised by staff to control numbers and to ensure that no nuisance is caused.

3. Doors and windows shall be kept closed after 23:00 hours other than for normal access and egress.

4. Notices shall be prominently displayed at exits to the premises requesting customers to respect neighbours and to leave quietly.

5. Telephone numbers for local taxi or private hire companies shall be made available to customers.

Protection of Children

1. A Challenge 25 proof of age policy shall be adopted and implemented at the premises whereby any person appearing to be under the age of 25 shall be required to produce photographic proof of age in one or other of the forms specified by the mandatory conditions, before being supplied with alcohol. Notices advertising the policy shall be displayed at the entrances to the premises and at bar serveries.

2. All staff concerned with the sale or supply of alcohol shall receive training on restricted sales (to persons under 18 and/or to persons who are intoxicated) and the conditions attached to the licence. Refresher training shall be carried out at least

annually. All training shall be documented in writing and the training records made available for inspection by the police and other authorised officers upon request.
3. No relevant (i.e. adult) entertainment shall be provided.
